A. NOTES TO ACCOUNTS

- 1. The Company has obtained regular registration under Foreign Contribution (Regulation) Act 2010 (FCRA) during the year 2023-24 effective from 30th November, 2023.
- 2. The reporting under FCRA has been done on Receipts and Payment Basis, however, the Company has also compiled and attached Income & Expenditure Account as per the requirement of Foreign Contribution (Regulation) Rules, 2011.
- 3. The administrative expenses are within 20% of the receipts during the financial year.
- 4. The company has entered into an agreement for foreign grant effective from 1st January 2024, however the amount was received only on 3rd April 2024. The expenses accrued for Jan to March 2024 have been provided for and paid in the next year.
- 5. This being first period, no previous period figures have been provided.
